 6. A DVD with a 5-minute excerpt of your dancing in a work, preferably in performance. If there is more than one dancer in the video please provide notes to identify you. Video MUST be on DVD.
 7. For those interested in choreography, please provide a 5-minute excerpt from a recently choreographed work. Footage MUST be on DVD.
